A certificate of interment rights is conveyed upon the completion of payment for interment rights in Beck's Restlawn Memorial Park.

Beck's Restlawn Memorial Park is an endowment care cemetery. An additional Endowment Care Fee equal to 15% of the above charges is deposited to the Restlawn Endowment Care Fund on a monthly basis. That fund is established under the laws of the State of Washington, and is maintained as a separate entity to provide for the care and maintenance of the cemetery.
